Lebanon buys home energy storage

Let"s face it--Lebanon"s energy sector has been running on fumes for years. With daily blackouts and aging infrastructure, the Lebanon power storage project bidding isn"t just another government tender. It"s a lifeline. But who"s this article for?

Gore Street Energy Storage Fund has acquired a 200MW battery storage project in development by Kona Energy. It marks the stock exchange-listed energy storage investment fund"s single largest project acquisition to date, bringing its total portfolio of contracted or operational battery energy storage system (BESS) assets to 898MW.

These include solar and storage company JPS Renewable Energy, for which Good Energy paid an upfront price of £7 million, Amelio Solar, which was sold at an initial consideration of £5.5 million; and most recently, solar installer Empower Energy, which was acquired on a debt-free basis for an initial £7 million consideration with an ...
