What are the extended warranty options for PV inverters?

How long do inverter warranties last?

Inverter warranties vary by manufacturer and inverter type. String inverters typically come with 10-12 years of warranty coverage, whereas microinverters and power optimizers are often covered for 25 years.

Does a solar inverter have a warranty?

Most solar inverter manufacturers leave workmanship (labor) warranties to the installer. Still, like labor and shipping costs, some manufacturers offer an extra safeguard by tacking on their own workmanship warranty coverage. When applicable, it's typically only an option if you work with specific installers in a manufacturer's certified network.

Do solar panels have a warranty?

Both your solar panels and inverters have their own warranties. A product warranty, which covers defects on the solar panels. For that, the industry standard is 5-10 years, with selected manufacturers offering up to 20 years. A power output warranty, which covers cases where the power output falls below the guaranteed levels.

How long does a solar inverter last?

While the warranty terms for inverters themselves vary, warranties for communications equipment (which allow the inverter to connect to other devices like solar panels and battery systems) are typically capped at 5 years for both string inverters and microinverters.

Are labor and shipping costs included in solar inverter warranties?

Labor and shipping expenses are generally not included in solar inverter warranties, but some of the strongest brands will cover one or both of these costs. Based on our ranking system, Hoymiles, SolarEdge, Tigo, SMA, and Enphase have the strongest warranties.
